Resolved that the Board of Education of the St. Lawrence-Lewis BOCES, does hereby approve the following agreement with the Administrators' Group and Non-Unit members employed by the St. Lawrence-Lewis BOCES, for the 2019-2020 fiscal year ending June 30, 2020 and for the 2020-2021 fiscal year ending June 30, 2021:

 2019-2020 – Administrators' Group and Non-Unit Members – Each member of the administrators' group and non-unit members will receive a \$3,852 flat rate raise based upon their pro rata share of the total 2019-2020 administrators and non-unit member payroll. The \$3,852 flat rate raise is for 12-month employees, those less than 12-months will be pro-rated.

- 2020-2021 Administrators' Group and Non-Unit Members Each member of the administrators' group and non-unit members will receive a 3.95% increase based upon their individual 2019-2020 salary.
- The Administrators' Group and Non-Unit Members Each member of the administrators' group and non-unit members will move to the Health Insurance Rider 11, with the contribution percentage unchanged.
