Term, which is attached hereto and made a part of this agreement as Attachment 'A' is hereby amended to reflect that the County has elected to extend the term of the agreement for the first five (5) year term, pursuant to Section 6. Renewal of Attachment 'A' and BOCES has acknowledged its responsibilities to comply with the County's election. This period will begin November 1, 2020 and continue through October 31, 2025.

Except as set forth in this Amendment, the Agreement is hereby reaffirmed and ratified as written and shall continue in full force and effect in accordance with its terms and the terms of this Amendment. If there is conflict between this amendment and the Agreement or any earlier amendment, the terms of this amendment shall prevail.
